Summer Utility Worker  
(Full-Time Summer Student Position)**

**The Valley Region Solid Waste-Resource Management Authority (Valley Waste-Resource Management)** is a regional solid waste-resource management authority under the Environment Act. The Authority operates the municipal solid waste system in the Valley Region. Valley Waste is seeking candidates to fill the seasonal full-time summer position of **Summer Utility Worker**.

The Summer Utility Worker reports to the Management Centre Site Supervisor and should be prepared to perform all functions of the job on a daily basis as listed below, alternating at the Kentville Management Centre and Lawrencetown Management Centres. The key functions of the position are:

**1) Groundskeeping and litter**

The Summer Utility Worker will assist with:

- General groundskeeping such as mowing, whipper snipping;
- Removal of litter from grounds;
- Painting;
- Other duties as required

**2) Customer Service and Special Event Support**

- Assist with directing customers at the public drop-off and C&D areas
- Provide support to the communications and enforcement team in collecting material from beach and litter clean-ups across the Valley Region.

**3) Working Conditions**

- Working on grounds near customer vehicles and heavy equipment;
- Potential travel on roads in the Valley Region;
- Adhering to Valley Waste-Resource Management Bylaw and Policies;

**The successful incumbent will be:**

- A self stater, willingness to work outdoors in most weather conditions,
- Have excellent people skills and an outgoing manner,
- Able and willing to work in a team environment or alone as required,
- Familiar with small engines, landscaping, grounds keeping would be an asset,
- Have a valid driver's license.

This is a temporary full-time position for 16 weeks starting approximately May 5, 2025 until August 29, 2025. Compensation includes a competitive wage of \$20.78/hr. Please submit your written application by 4:30pm, Friday, April 15, 2025. **Submissions should outline the applicant's education, past experience, training and other related qualifications that would allow the applicant to successfully perform the duties of the position.**
